

## IN YEAR SCHOOL ADMISSION PROCEDURE 2025/2026

Fairfield High School for Girls co-ordinates its own **in-year** school admissions.

### The Application Process

Once you have submitted your in-year online application you will be sent an automated response confirming that your application has been received.

Upon receipt of your in-year online application the Admissions Committee will **endeavour** to notify parents/carers (in writing) within **10** school days of the outcome of their application. All parents/carers **must** be notified (in writing) within **15** school days.

Where an application is refused parents/carers **will** be informed of the reason for the refusal of a place and provided with information about the right to appeal.

Where an offer of a place is made parents/carers will be notified of this (in writing) and provided with details of a named person to contact to make an appointment for an admission meeting.

Even though we are conducting our own in-year admissions we will continue to work closely with Tameside Local Authority in ensuring that they remain fully informed of each application we receive and its outcome.

For applications received directly to school we will provide the Local Authority with details of place availability within **two school days** of any request received.

Where the Local Authority receives an in-year application for this school, they will immediately forward this onto us for processing (within **two school days** of receiving this).

Whenever the school receives an application from the Local Authority, it will notify the Local Authority of its outcome as soon as reasonably practicable (within **two school days** of any decision made).

All in-year applications received will be considered and processed in the order they are received (e.g. date order).

The Admissions Committee reserves the right to give special consideration to twins, triplets or multiple birth siblings in the event that an application is received. For example - if there is one place available in a particular Year Group and an application is received from a parent/carer who has twins, triplets etc. the school will go above its Published Admission Number (PAN) to prevent breaking the sibling link.

## **Waiting Lists**

If your child is refused a place; their name will be added to the school's in-year transfer applications waiting list for the relevant Year Group.

## **Appeals**

Parents/carers, who wish to appeal against the decision of the Admissions Committee to refuse admission to Fairfield High School, should do so in writing, setting out clearly why your child should go to Fairfield High School.
